


Further, Pachhunga University College shall take up Ph.D admission processes at their College level for those Departments that are not presently existing in the Main Campus of MZU such as Life Sciences, Geophysics and Philosophy.

However, in the case of Departments based in the Main Campus, each Department shall undertake PhD admission processes at department level and shall have discretion to allot PhD supervisors from eligible teachers of the Department as well as from among recognised supervisors of the same department in a constituent / affiliated College or as it deems appropriate. The Council also resolved that Co-guide may be appointed in the event that a Guide is appointed from Colleges located at remote areas.
