10. As per rule 211 of GFR the accounts of Grantee Institution shall be open to inspection by the sanctioning authority / audit whenever the institute is called upon to do so.



Sanction of Science and Engineering Research Board (SERB) is hereby accorded to the above mentioned project at a total cost of **Rs. 3942500/- (Rs. Thirty Nine Lakh Forty Two Thousand Five Hundred Only)** with break-up of **Rs. 900000/- under Capital (Non-recurring) head** and **Rs. 3042500/- under General (Recurring) head** for a duration of 36 months. 14. The project File no. EEQ/2018/000805 may also be mentioned in all research communications arising from the above project with due acknowledgement of SERB.




