Council of Scientific and Industrial Research (CSIR) - North East Institute of Science and Technology, Jorhat 785006, Assam which is a constituent unit of the Council of Scientific and Industrial Research, having its registered office at Anusandhan Bhavan, 2, Rafi Marg, New Delhi – 110 001, (hereinafter referred to as CSIR-NEIST) through its authorized representative, the Director, as the one part;

And

Pachhunga University College (PUC), is the only constituent College of Mizoram University. The college was founded as Aijal College in the year 1958 and it is the oldest and the largest college in Mizoram, situated in Aizawl, Mizoram : 796001 (hereinafter referred to as **PUC**), through its authorized representative, the Principal, Pachhunga University College, Aizawl, Mizoram as the other part.

Both **CSIR-NEIST** and **PUC** shares a common desire to explore, extend and strengthen the functional relationship between College and National Scientific Institutes. **PUC** and **CSIR-NEIST** in order to share the facilities and expertise available in each other's institution herewith sign this Agreement cum Memorandum of Understanding.

1. PREAMBLE:

- 1.1. CSIR-North East Institute of Science and Technology (CSIR-NEIST), Jorhat, Assam, a constituent establishment of Council of Scientific and Industrial Research, a society registered under the Societies Registration Act XXI of 1860 and having its registered office at Anushandhan Bhawan, 2, Rafi Marg, New Delhi 110 001.
- 1.2. Pachhunga University College (PUC), is the only constituent College of Mizoram University. The college is a premier institution of higher education in the North-East India situated in Aizawl, Mizoram. The college provides quality education offering Bachelor and Masters Degrees. The college has been reaccredited by National

Assessment and Accreditation Council (NAAC) with A+ grade with a CGPA of 3.51 in 2016, the highest score in Mizoram. The National Institutional Ranking Framework (NIFR) by the Ministry of Human Resource Development listed it among the best 150 colleges in India. The college has received the Indira Priyadarshini Vrikshamitra Awards in 1995, for pioneering and innovative works in afforestation and wasteland management. The Department of Science and Technology, New Delhi awarded the college with a special scheme of Fund for Improvement of Science and Technology Infrastructure (FIST), the project was then coordinated by CSIR-NEIST, Jorhat. The Department of Biotechnology, New Delhi has set up Institutional Biotech Hub, which was upgraded to Advanced Institutional Biotech Hub and was awarded the Star College status. The college has also received 'Indira Gandhi NSS Awards' in 2016 for its outstanding contribution to the service of the community at various levels.

2. PURPOSE AND OBJECTIVES:

- 2.1. The broad purpose of this Agreement and MoU is to promote cooperation in scientific education and research between **PUC** and **CSIR-NEIST**, Jorhat. The mutual collaboration will enable the utilization of each other's strengths in teaching and research, which in turn, will mutually benefit the students and faculty members of both the organizations and to create a framework for such a platform of collaboration.
- 2.2. The specific purpose of the Agreement is towards monitoring of the seismic activities in and around Mizoram. CSIR-NEIST, Jorhat would facilitate installation of BB-Sesimometers along with digitizers for 03 numbers of seismic stations to be set up at Aizawl, Champhai and Lunglei. PUC would provide all required logistics, maintainance, security and monitoring of data generated with the instruments, etc.

3. AREAS OF CO – OPERATION:

- 3.1. The General Areas of Cooperation would include the followings:
 - To establish a close linkage and functional coordination between CSIR-NEIST and PUC.
 - b. To recognize CSIR-NEIST as partnering research institute of PUC.

- c. To facilitate the Bachelors/Masters students of PUC to conduct project works in CSIR-NEIST under the supervision of the faculty members of CSIR-NEIST/joint supervision of the faculty members the both institutes.
- d. To consider the CSIR-NEIST professional as accredited supervisor/guide/instructor for PUC teaching and research programme and vice versa.
- e. To facilitate joint seeking of funds and conduct of research, submission of projects for research and development in the fields of mutual interest, exchange of visiting research scholars.
- f. Opportunities for faculty and staff development and exchange through training programmes.
- g. To facilitate creation/development of new experimental and research/training facilities through mutual co-operation of CSIR-NEIST and PUC through exchange of experts, etc.
- h. On the mutual agreement, specialized and short duration refresher courses / training programmes on the topics of interest to the industry / academia can be jointly offered at CSIR-NEIST or PUC. The resources for such activities shall be shared.
- i. To facilitate other form of cooperation like hosting conferences, seminars, etc. mutually agreed between CSIR-NEIST and PUC.
- j. Any intellectual property arising out of the joint intellectual input under a collaborative R&D project will be held jointly, filing and maintenance cost of which shall also be shared equally. The responsibility of filing and maintaining the intellectual property shall be vest with CSIR on a case to case basis. However, in the event of licensing of the IP for commercialization by CSIR-NEIST or PUC to any third party, the terms of such release will be decided mutually and the release will be covered by a separate agreement and also money accrued will be shared between CSIR-NEIST and PUC at a proportion to be mutually decided from case to case basis after deducting the cost of patenting borne by CSIR on behalf of PUC. In case PUC does not want to be a party to the intellectual property, Director, CSIR-NEIST shall take an appropriate decision regarding its filing and utilization. PUC shall not file any application for seeking Intellectual Property Rights on its own name or in the name of its associates or any other

person on any matter relating to the information gathered / disclosed to it by CSIR-NEIST.

- k. CSIR-NEIST and PUC shall consult each other for any publication in respect of any project/course work, These publications shall be in the name of research worker, wherein resource persons of both the institute will be duly acknowledged.
- To facilitate the students of PUC for experimental work at CSIR-NEIST in selected areas.
- m. To take care of accommodation facilities of CSIR-NEIST professionals by PUC and vice versa.
- n. Any expenditure incurred through the joint programmes will be borne as per mutual agreement.

3.2. The Specific areas of immediate cooperation are:

a. Installation of BB-Sesimometers along with digitizers for 03 numbers of seismic stations to be set up at Aizawl, Champhai and Lunglei by CSIR-NEIST, Jorhat and maintenance, monitoring of data, etc by PUC.

4. ROLE OF CSIR-NEIST, JORHAT:

4.1 General Role

- a. To provide infrastructural and relevant facilities for the successful realization of the above mentioned objectives.
- b. To facilitate the organization of different programmes in the Institute premises through mutual discussion.
- c. The students and faculty members of **PUC** to access the library and instrumentation facility of **CSIR-NEIST**.

4.2 Immediate Specific Role

- Provide seismic instrumentation;
- b. Provide technical support;
- c. Training to the staff of Pachhunga University, College;

5. ROLE OF PACHHUNGA UNIVERSITY COLLEGE:

5.1 General Role

- a. To provide infrastructural and relevant facilities for the successful realization of the above mentioned objectives.
- b. To facilitate the organization of different programmes in the Institute premises through mutual discussion.
- c. The students and faculty members of CSIR-NEIST to access the library and instrumentation facility of PUC.

5.2 Immediate Specific Role

- Provide logistics for transportation of instruments.
- Provide local hospitality for the scientists/ technical assistants of CSIR-NEIST during installation.
- c. Provide maintenance of instruments including power supply.
- d. Provide building for set-up of stations.
- e. Provide security for the instruments.
- f. Share data with CSIR-NEIST Jorhat.
- g. Return the instrument to CSIR-NEIST as and when requested.
- h. Ensure all kind of Administrative/Bureaucratic help from the Govt. of Mizoram.

6. RESULTS OF COLLABORATION:

- 6.1 Data generated from the activities under the MoU shall be shared amongst the party members involved in the Parties' collaboration without any delay, for archiving, analysis and preparation of scientific documents (report, paper etc).
- 6.2 The intellectual property that is [knowhow / process / design / technique / patents / copyrights] generated under the MoU shall be jointly owned by CSIR-NEIST and PUC; the extent of ownership shall be decided mutually depending upon the relative inputs [intellectual / technical / financial / physical] made by the parties hereto to the activities under the MoU.
- 6.3 The procedural formalities for securing and maintaining the intellectual property rights [patents / trademark / copyright] if any, shall be the responsibility of CSIR-NEIST and PUC. The question of whether or not intellectual property right should be secured shall be mutually decided.

6.4 The parties shall consult each other for any publication in respect of the MoU. These publications (papers, reports etc.) shall be in the name of research workers, wherein it will be duly acknowledged that the work has been carried out under the collaboration between the parties.

7. CONFIDENTIALITY:

- 7.1 Each Party agrees to use any confidential information (as defined below) of the other party disclosed under this MoU solely for the purposes of this MoU. "Confidential Information" means any information in any form that is marked at the time of disclosure as being "Confidential" or words of similar meaning.
- 7.2 Neither of the parties shall, without the prior written consent of the other party, disclose any confidential information relating to this MoU to any third party.
- 7.3 Each Party agrees to make confidential information available only to those employees and students who require access to it in the performance of this MoU, and to inform them of the confidential nature of such information and their obligation to project such confidentially. Each Party shall exert reasonable efforts, no less than the protection given its own confidential information, to maintain such information in confidence.
- 7.4 Each Party agrees that the obligations of confidentiality contained herein shall not attach to information that is required to be disclosed by court rule or government law or regulation, provided that the Receiving Party gives the Disclosing Party prompt notice of any such requirement and cooperates with the Disclosing Party in attempting to limit such disclosure.
- 7.5 The obligation of confidentiality hereunder shall carry on in force for a period of Three (3) years from the termination or expiry of this MoU.
- 7.6 Nothing in this MoU constitutes or implies any representation, warranty or undertaking by the disclosing party of the accuracy or completeness of the information or materials provided as part of its involvement hereunder.
- 7.7 Disclosing Party may demand the return of the Confidential Information (a) at any time by giving written notice, (b) on expiry of terms of Disclosing Party or (c) termination of services of Disclosing Party giving written notice to Receiving Parties. Within seven (7) days of receipt of such demand of Disclosing Party, Receiving Parties shall return all of the original Confidential Information and shall destroy or cause to be destroyed all copies in its possession and in the possession of persons

to whom it was disclosed pursuant to this Agreement to the satisfaction of Disclosing Party and provide a certification to the Disclosing Party that such Confidential Information has in fact been destroyed.

8. <u>REVIEW AND TERMINATION:</u>

- 8.1 This MoU shall commence from the effective date of signing for a period of five (5) years (Initial Term). The MOU will automatically lapse after five years, unless renewed.
- 8.2 This MoU will be renewed based on mutual consent.
- 8.3 Either party shall be entitled at any time at its absolute discretion to terminate this MoU by giving at least three (3) months prior written notice to the other party. Such termination shall not affect the implementation of the activities established under this MoU prior to the effective date of the termination.
- 8.4 Each Party shall ensure that adequate arrangements have been made to complete all commitments before this MoU is terminated.
- 8.5 Any disputes arising out of the arrangement shall be settled by mutual negotiation between two parties.

9. VARIATION AND MODIFICATION

This MoU may be varied or amended by agreement in writing and signed by both Parties.

10. DISPUTE RESOLUTION

- 10.1 The parties agree that mutual goodwill and understanding forms the basis of this MoU. Nothing mentioned in this MoU shall deem to constitute partnership between the signing Institutions appointing one party as an agent of the other. This MoU will be effective upon signature by the authorized signatories of the Institutions.
- 10.2 Any dispute arising out of or in relation to this MoU shall be settled by the parties amicably through mutual consultations and negotiations. Except as herein before provided, all disputes arising out of or in connection with this agreement shall be referred the Arbitration Centre, New Delhi. The decision of the arbitrator shall be final and binding on both the parties. The venue of arbitration shall be in New Delhi and the arbitration proceedings shall take place under the Indian Arbitration and Conciliation Act 1996 (as amended from time to time).

- 10.3 Each party shall bear and pay its own cost of the arbitration proceedings unless the Arbitrator otherwise decides in the Award. The language of arbitration proceedings will be English only
