# Concept Note

---

The School of Humanities and Languages at Mizoram University is proposing an International Seminar with the aim of engaging in academic discussions regarding the environmental challenges currently affecting humanity and the planet Earth on a large scale. We will focus on critical studies and issues that emphasize the value of ecological relationships, spanning multiple disciplines, including culture, literature, and philosophy.

The concept note for this proposed seminar aims to examine the state of environmental justice and reevaluate the ecological awareness that humanities subjects have inspired in a world facing critical environmental issues.

It is essential to highlight that the natural world, which encompasses human and animal life, is under serious threat from various sources. Relentless human exploitation of nature, uncontrolled mechanization encroaching upon green areas, unchecked pollution, environmental contamination, and climate change are some glaring examples that have left our world in devastation, disease, and decay. Planet Earth appears to be on the brink of ecological collapse.

Cultural, philosophical, literary, and scientific studies, both in the past and present, indicate a lack of genuine concern for environmental values or the adoption of half-hearted measures for an ecologically sustainable world. While humanities subjects emphasize ecological responsibilities, the fields of science and technology often align with state politics and electoral pressures, perpetuating humanist progress paradigms worldwide. The competitive pursuit of political and economic power has failed to eliminate the inclination toward war and the stockpiling of armaments. Poverty, illiteracy, hunger, and disease persist despite graphs of civilized progress. Our unbridled pursuit of 'growth' has imposed technology on nature that is far from eco-friendly. In the face of real and potential threats to living organisms and life systems on our planet, most environmentally conscious thinkers, NGOs, and institutions strongly condemn our disregard and apathy toward environmental justice.

We acknowledge the urgent need to better preserve the Earth, our shared home. Therefore, we extend an invitation to scholars, researchers, and experts from India and abroad to participate in the proposed International Seminar with the main theme of "Environmental Justice: Representations in Culture, Literature, and Philosophy."

Depending on the availability of funds, the seminar also plans to publish selected research papers as part of a seminar volume to contribute to the academic field of knowledge. All Heads of Departments (HODs) from the Departments of English and Culture Studies, Mizo, Hindi, and Philosophy, for this multidisciplinary International seminar, are encouraged to actively participate as members of the Steering Committee.
